

**AMENDMENT No. 6 - 2021 TO
Enterprise Agreement for Services
CONTRACT NUMBER GTA000187-012**

This Amendment No. 6 - 2021 is made this 21 day of May, 2021, by and between the **GEORGIA TECHNOLOGY AUTHORITY ("GTA")** and **SOUTHERN COMMUNICATIONS SERVICES, INC. D/B/A SOUTHERN LINC** ("Contractor").

WHEREAS, heretofore GTA entered into that certain Enterprise Agreement for Services on December 30, 2013 ("Agreement") certain products and services to be provided to GTA by the Contractor, as more particularly described therein:

WHEREAS, the parties wish to amend the Agreement to reflect certain changes.

NOW, THEREFORE, in consideration of the premises, the terms and conditions stated herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Definitions. All capitalized terms used herein and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.
2. Successors and Assigns. This Amendment No. 6 - 2021 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
3. The term "Agencies" in the Agreement is hereby updated from:

"As referred to in this Agreement "Agencies" shall include any and all State of Georgia entities, including but not limited to, departments, agencies, authorities, commissions, boards, college and universities, counties, cities, townships and other political subdivisions of the State."

To:


"As referred to in this Agreement "Agencies" shall include any and all State of Georgia entities, including but not limited to, departments, agencies, authorities, commissions, boards, college and universities (including not for profit Georgia college and universities), counties, cities, townships and other political subdivisions of the State."

4. Entire Agreement. Except as expressly modified by this Amendment No. 6 - 2021, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations of the parties. This Amendment

No. 6 - 2021 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.


